*Glen Rock MS/HS HSA is a member of Boiling Springs Savings Bank's Community Alliance Program to help us earn extra money.*



**How the Program Works:** The program gives our organization the opportunity to earn money based on the number of members who bank with Boiling Springs. Once we meet the requirements of the Community Alliance Program, Glen Rock MS/HS HSA will receive quarterly donations based upon the average balance of our supporter's designated accounts or loans at Boiling Springs.

Since the program's inception in 2006, the bank has donated over \$2,710,000. To date, 409 non-profit organizations have joined the program.

### **How Glen Rock MS/HS Home+School Assn. Supporters Can Help Us Earn Extra Money:**

Supporters can help us earn money by opening new accounts or loans or by having existing accounts at Boiling Springs and designating them as Community Alliance participants. Once we reach a minimum of twenty individual account holders and/or businesses that have designated their accounts or new loans our organization will receive a quarterly reward. Rewards are based on the Average Daily Balance maintained by the members at the Annual Rate of: 0.25% on Certificates of Deposit, including IRA CDs, Premium and Money Market Checking, and all Business Accounts or 0.50% on other Checking, Savings, and Money Market Savings Accounts. For loans: 0.10% for the life of the new loan on Mortgage and Home Equity Loans or 0.10% on outstanding new loan balances on Home Equity Lines of Credit. Loan customer must affiliate with a CAP group within 60 calendar days of origination. **No monies are withdrawn from donor's accounts and all donation dollars come directly from Boiling Springs.**
